## **Objectives**

The Association was organized to assist its members to gain and maintain leadership in their profession and through collective efforts to advance the professional standards of this specialized branch of human resources management.

## **Membership**

### Regular Membership

Shall include those persons having interest in and responsibility for the hospital human resource function. The rights and privileges of regular membership include the right to vote and hold office in the Association.

### Associate Membership

Persons outside the foregoing category who demonstrate to the Association a bona fide interest in hospital human resource administration and in the purposes of the Association shall be eligible for associate membership. Persons whose employment or business might involve the offering of goods or services to members, intended for hospital use, will be excluded from membership. Associate members shall have no vote and may not hold office in the Association. Annual dues for this category of membership shall be the same as regular membership.

## **Goals**

- A. Provide a means for the collection, publication, and distribution of other data relating to hospital human resources management and supervision.
- B. Build an interest in the development of human resources organizations for the purpose of strengthening employee management relations, supporting the development of the employees, increasing administrative effectiveness, and obtaining greater publicity.
- C. Bring forth an organized means for the exchange of ideas and experiences in the human resources field, utilizing a variety of professional and social contacts.
- D. Promote fundamental and systematic training of persons engaged in the hospital human resources field.
